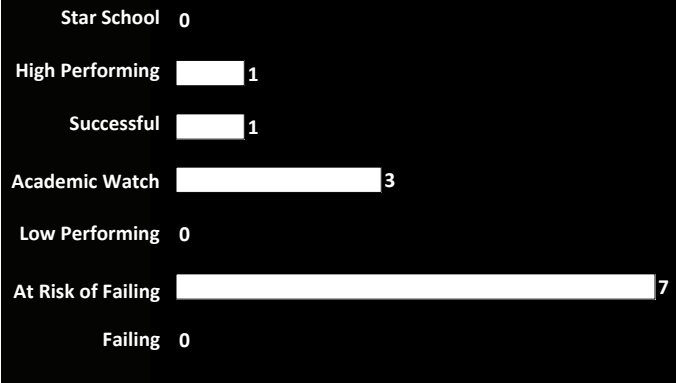

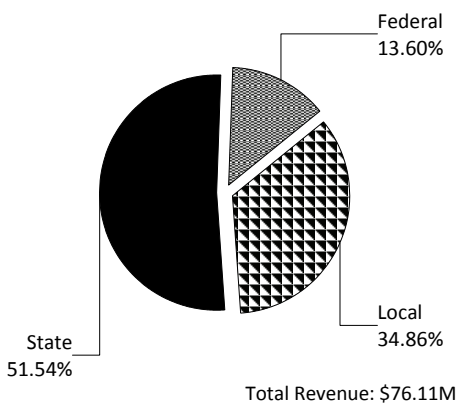

Revenue Sources



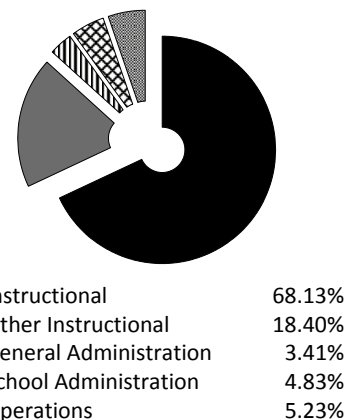
